

Subscription and License Agreement

This is a legal agreement (hereinafter “Agreement”) between you (hereinafter “Subscriber”), the party subscribing to the My Yesterday software (hereinafter “My Yesterday”), and Covered Bridge Independents, LLC, a corporation having offices at 5570 Library Road, Bethel Park, PA 15102 (hereinafter “CBI”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the parties hereto agree as follows:

1. Definitions

- a. "Software" means MY YESTERDAY software with the current functionality and tools feature provided by CBI. It also includes any accompanying instructions, documentation, technical data, images, recordings, and other related materials.
- b. "Use" means use of the Software over the Internet delivered to the Subscriber by way of CBI' or third party servers ("Server"), which allows access to the MY YESTERDAY Internet web sites.
- c. "Product" means the MY YESTERDAY Software product and its documentation as built at the time of Subscriber's use.
- d. "License" means the Software license grant and general license terms set forth herein.
- e. "Terms of Use" means any and all prohibitions and restrictions on Use, including any activities engaged in by way of Servers or in any personal workgroup or environment available via that Server.
- f. "Term of Agreement" shall be for 12 months or until Subscriber's credits for creating MY YESTERDAY BOOKS using the Software have been used, expire or are terminated in accordance herewith.
- g. "Subscriber" means the individual or entity who purchases the subscription under this Agreement.
- h. "Customer" means any entity or individual who uses the Software through Subscriber's subscription.
- i. "This Agreement" means this entire Subscription and License Agreement.

- j. "Reissue" means a product similar to the original Product subscribed to, but updated to include those features and fixes that are included in the current release.
- k. "Upgrade" means a new release of the Product that includes a substantial new facility or capability.
- l. "Data" means any information collected from the Subscriber and/or Customer during use of the Software hereunder.

2. Subscription Terms

- a. Fees for the Software Subscription and License are set forth in Exhibit A.
- b. CBI may terminate this Agreement including the License immediately without prior notice for failure to comply with any term of this Agreement including, without limitation, the provisions of Sections 3 and 5 hereof. Immediately upon termination, Subscriber shall no longer have any right to use the Product.
- c. Upon termination of this Agreement or of any credits issued to Subscriber for creating MY YESTERDAY BOOKS, no credit will be issued to Subscriber for any monies previously paid to CBI.
- d. Subscriber may not assign or transfer this Agreement. Any such attempted assignment or transfer shall be null and void. CBI may immediately terminate this Agreement without notice in the event of any such attempted assignment or transfer by Subscriber.

3. License Grant and Terms

- a. During the Term of this Agreement, Subscriber will have a license that entitles the Subscriber and Customers to access the Software.
- b. All rights, title and interests in and to the Software are owned by or licensed to CBI. The License confers no right, title or interest of any kind in the Product to Subscriber or any Customers and is not a sale of any such rights in the Software. Subscriber and Customers are granted only the right to use the Product without right of sublicense.
- c. Subscriber and Customers must retain all patent, copyright notices and other proprietary legends in or on the original Software. Subscriber and Customers may not remove from the Software, or alter, any of the CBI trademarks, trade names, logos, patent or copyright notices or markings, or add any other notices or markings to the Software.

d. Subscriber and Customers may not modify, reverse engineer, disassemble, decompile or otherwise attempt to access or determine the source code of the Software, copy, reproduce or distribute the Software in any way in whole or in part or create any derivative work based on the Software. Any use of the Product on any other website or networked computer environment for any purpose is prohibited. The Software is copyrighted and any unauthorized use of it is prohibited. If Subscriber and/or Customer(s) breach any of these terms, the License to use the Software automatically terminates and Subscriber and Customers must immediately destroy any downloaded or printed materials related to the Software.

e. Subscriber and Customers agree that Software contains proprietary information including trade secrets, know how, flow charts, logic diagrams, user manuals and/or display screens that are confidential to and the exclusive property of CBI ("Confidential Information"). During the Term of this Agreement and at all times after its termination, Subscriber, Customers and their employees and agents shall maintain the confidentiality of the Confidential Information and not sell, license, publish, display, distribute, disclose or otherwise make available the Confidential Information to any third party nor use the Confidential Information in any manner or for any purpose without the prior written consent of CBI.

f. As used herein "Confidential Communication" means any communication between Licensor and Licensee including but not limited to voice such as, for example, face-to-face, telephonic and voice over internet protocol (VOIP), data such as, for example, hard-copy, facsimile, text message and electronic mail and other forms of communication now known or hereafter devised. Licensor and Licensee hereby agree to consider and treat all communications involving the My Yesterday Software as Confidential Communications between Licensor and Licensee. Licensor further warrants that it will not now or at any time in the future sell any of Licensee's personal contact information to any third-party.

4. Disclaimers and Limitations

a. TO THE EXTENT ALLOWED BY LAW, THE SOFTWARE AND THE ACCESS TO ANY RELATED SOFTWARE SERVICES ARE PROVIDED TO SUBSCRIBER "AS IS" WITHOUT WARRANTIES OR CONDITIONS OF ANY KIND, WHETHER ORAL OR WRITTEN, EXPRESS OR IMPLIED. CBI SPECIFICALLY DISCLAIMS ANY IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY, SATISFACTORY QUALITY, NON-INFRINGEMENT, TITLE, ACCURACY OF INFORMATIONAL CONTENT, AND FITNESS FOR A PARTICULAR PURPOSE, THE ENTIRE RISK AS TO THE RESULTS AND PERFORMANCE OF THE SOFTWARE IS ASSUMED BY SUBSCRIBER AND CUSTOMERS. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY CBI OR CBI AUTHORIZED REPRESENTATIVES SHALL CREATE A WARRANTY. CBI DOES

NOT REPRESENT THAT ITS SERVERS WILL BE AVAILABLE AT ALL TIMES OR WILL BE FUNCTIONING PROPERLY WHEN SUBSCRIBER OR OTHERS WISH TO ACCESS THE FUNCTIONALITY OF THE SOFTWARE HEREUNDER. CBI'S SERVERS MAY BE UNAVAILABLE AT TIMES FOR MAINTENANCE OR FOR A VARIETY OF OTHER REASONS. CBI SHALL NOT BE LIABLE TO SUBSCRIBER OR CUSTOMERS FOR ANY PERIODS OF UNAVAILABILITY AND SUBSCRIBER AND CUSTOMERS SHALL NOT BE ENTITLED TO ANY REFUNDS FOR THOSE PERIODS WHEN THE SERVERS ARE NOT AVAILABLE OR ARE NOT FUNCTIONING PROPERLY. SOME JURISDICTIONS DO NOT ALLOW EXCLUSIONS OF IMPLIED WARRANTIES OR CONDITIONS, SO THE ABOVE EXCLUSION MAY NOT APPLY TO THE EXTENT PROHIBITED BY APPLICABLE LAWS.

b. EXCEPT TO THE EXTENT PROHIBITED BY LAW, IN NO EVENT SHALL CBI OR ITS SUBSIDIARIES, AFFILIATES, DIRECTORS, OFFICERS, EMPLOYEES, AGENTS, CONTRACTORS OR SUPPLIERS BE LIABLE FOR DIRECT, INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL, PUNITIVE, OR OTHER DAMAGES (INCLUDING WITHOUT LIMITATION LOST PROFITS, LOST DATA, OR DOWNTIME COSTS), ARISING OUT OF THE USE, INABILITY TO USE, OR THE RESULTS OF USE OF THE SOFTWARE, WHETHER BASED IN WARRANTY, CONTRACT, TORT OR OTHER LEGAL THEORY, AND WHETHER OR NOT CBI WAS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. CBI' AND ITS SUPPLIERS' ENTIRE LIABILITY AND SUBSCRIBER'S AND/OR CUSTOMERS' EXCLUSIVE REMEDY SHALL BE, AT CBI'S OPTION FROM TIME TO TIME EXERCISED SUBJECT TO APPLICABLE LAW, (A) RETURN OF THE CURRENT MONTH SUBSCRIPTION PRICE PAID (IF ANY) FOR THE USE OF THE SOFTWARE, OR (B) REPAIR OR REPLACEMENT OF THE CURRENT VERSION OF THE SOFTWARE.

c. EXCEPT TO THE EXTENT ALLOWED BY LOCAL LAW, THESE WARRANTY TERMS DO NOT EXCLUDE, RESTRICT OR MODIFY, AND ARE IN ADDITION TO, THE MANDATORY STATUTORY RIGHTS APPLICABLE TO THE LICENSE OF THE SOFTWARE TO SUBSCRIBER AND/OR CUSTOMERS; PROVIDED, HOWEVER, THAT THE UNITED NATIONS CONVENTION ON CONTRACTS FOR THE INTERNATIONAL SALE OF GOODS IS SPECIFICALLY DISCLAIMED AND SHALL NOT GOVERN OR APPLY TO THE SOFTWARE PROVIDED IN CONNECTION WITH THIS AGREEMENT.

d. CBI DOES NOT PROMISE THAT THE SOFTWARE WILL FUNCTION ON OR BE COMPATIBLE WITH SUBSCRIBER'S OR CUSTOMERS' COMPUTER SYSTEM OR WEB BROWSER. CBI DOES NOT PROMISE OR WARRANT THAT SUBSCRIBER'S OR CUSTOMERS' COMPUTER SYSTEM OR WEB BROWSER WILL BE COMPATIBLE WITH THE FUNCTIONALITY AVAILABLE THROUGH OUR SERVER. IT IS SUBSCRIBER'S AND CUSTOMERS' SOLE RESPONSIBILITY TO ENSURE THAT THEIR RESPECTIVE COMPUTER SYSTEMS, WEB BROWSERS AND/OR

INTERNET ACCESS ARE COMPATIBLE WITH THE SOFTWARE AND CBI'S SERVER FUNCTIONALITY.

e. The disclaimers, exclusions and limitations of liability set forth in this Agreement form an essential basis of the bargain between the parties, and, absent any of such disclaimers, exclusions or limitations of liability, the provisions of this Agreement, including, without limitation, the economic terms, would be substantially different.

5. Terms of Use

a. As a condition of Use of the Software, Subscriber may not use the Software for any purpose that is unlawful or prohibited by this Agreement. CBI reserves the right to delete inappropriate material and to suspend or terminate this Agreement if the Software is used for an unauthorized purpose.

b. CBI stores and preserves Submitted Information and Data in accordance with established policy and may disclose it if required by law or in the good faith belief that such disclosure is reasonably necessary (a) to comply with legal process, (b) to enforce this Agreement, (c) to respond to claims that any user content violates the rights of third-parties, or (d) to protect the rights, property and personal safety of CBI and its employees, contractors, suppliers and vendors.

6. General Provisions

a. This Agreement and any disputes arising hereunder shall be governed by the laws of Pennsylvania, United States of America, without regard to conflicts of laws principles. Subscriber and Customers hereby expressly consent to the jurisdiction and venue in Allegheny County, Pennsylvania, over any disputes arising from or related in any manner to this Agreement. The parties and Customers hereby expressly exclude the application of the U.N. Convention on Contracts for the International Sale of Goods to the Agreement.

b. If any term or provision herein is determined to be illegal or unenforceable, the validity or enforceability of the remainder of the terms or provisions herein will remain in full force and effect. Failure or delay in enforcing any right or provision of this Agreement shall not be deemed a waiver of such right or provision with respect to any subsequent breach. Provisions herein which by their nature extend beyond the termination this Agreement shall remain in effect until fulfilled.

c. This Agreement is the final, complete and exclusive agreement between the parties relating to the subject matter hereof, and supersedes any previous communications, representations or

agreements between the parties, whether oral or written, regarding transactions hereunder. Any Subscriber additional or different terms and/or conditions shall not apply.

d. Subscriber and Customers shall be responsible for, and agree to comply with, all applicable laws, statutes, ordinances, regulations and other types of government authority including, without limitation, the laws and regulations governing export control, unfair competition, anti-discrimination, false advertising, privacy and data protection, and publicity.

e. Subscriber agrees to defend and indemnify CBI and hold CBI harmless from all claims, losses, damages, complaints, or expenses connected with or resulting from Subscriber's and/or its Customers' use of the Software.
